



Drawings – Competition rules

2021 Cevaa Jubilee

From April 20th to May 31st, 2021

Organized by Cevaa – Community of Churches in Mission

Article 1: Context and objectives

Cevaa – Community of Churches in Mission organizes, as part of its jubilee, a drawing competition for an exhibition at its General Assembly which will take place in 2021. We wish to make children aware of the diversity of the churches in the community but also to remind adults, parents and supervisors, the role of Cevaa.

Article 2: Theme

The following theme is proposed: **Draw me the Cevaa!**

Cevaa is a community of 35 Churches on 4 continents, and his slogan is: “**sharing in action**”.

Article 3: Participation criteria

The drawing competition is open to children aged 8 to 12. Participation in this competition is free. One drawing per person.

The drawings must be made in A4 or 20x30 cm format. The weight of the paper should be 80 to 300gr/m², unfolded. All manual techniques are accepted: paint, felt-tip pen, pencil, collage. No digital drawing.

Article 4: Items to be submitted

A participation form must accompany each drawing. The name, first name and age of the participants, their email address, their city and the Church to which they belong must obligatorily be included.

A copy of the registration form is available on request at secretariat@cevaa.org. No personal inscription should appear on the drawing.

The drawing and the participation form must be sent to the following email address: secretariat@cevaa.org ; the drawing will be scanned in high definition (resolution of 300 dpi minimum), the submission date is no later than **May 31, 2021** at midnight.

One drawing per Church will be selected by the jury, by majority vote.

Be careful, keep the digitized drawings in a safe place because the original drawings of the winners will be exhibited during the General Assembly and must therefore be sent by post to the Cevaa Secretariat. The details for this shipment will be given to you later.

Article 5: Composition of the jury

A jury will meet on **Monday June 7th**, to select the winners.

The jury will be made up of two members of the Secretariat, one member of the Executive Council and the General Secretary of Cevaa. The designation of the winners will be made by majority vote. Then, they will be individually notified.

The jury is sovereign, no complaints will be accepted.

Article 6: Media for publication of drawings

The selected drawings will be published in the collection of prayers published by Cevaa - Community of Churches in Mission, as part of its Jubilee festivities in 2021. The drawings will also be published on the www.cevaa.org website and the Cevaa Facebook page. They will be exhibited at the Cevaa General Assembly, which will take place from **October 2nd to 9th, 2021** in Bossey, Switzerland. The name of the child and his Church will be mentioned for each drawing.

This competition will respect the following schedule:

April 20th: opening of the competition

May 31st: end of the presentation of drawings and of the competition

June 7th: designation of the winners.

Article 7: Right of use

The organizer is free to use the drawings as he wishes for his action. Participants in this competition authorize the organizer to use their design for any event related to this competition, including their exhibition or publication. By participating in this competition, the authors agree to assign all rights in their drawing to the organizer.

Article 8:

The simple act of participating implies acceptance of these rules.

Article 9:

The organizer reserves the right to modify or interrupt the competition at any time if the circumstances so require, and without justification. He also reserves the right to rule on all difficulties in the interpretation or application of these regulations.

Article 10: Permission to access to personal information

The personal data collected in the participation form are mandatory in order to allow this competition to be carried out.

They are intended for the organizing company, Cevaa, in its capacity as data controller, for the following purposes: participation in this competition and management of the winners.

Personal data will be kept only for the duration of the competition.

With regard to personal data concerning them, participants have, in accordance with the **Data Protection Act of 6 January 1978 and the European Regulation on the protection of personal data which entered into force on 25 May 2018**, a right of access, a right of rectification in the event that this information turns out to be inaccurate or incomplete, a right of opposition, a right to erase personal data concerning them, a right to limit the processing of their personal data, as well as a right to portability, that is a right to receive and transmit personal data in a structured format commonly used and machine-readable.

Participants have the right to lodge a complaint with the CNIL if they believe that their rights over their personal data have been violated.
